## **2.1 Resolution of Continued Commitment to the West Parry Sound Area Recreation and Culture Project**

### **Resolution**

Whereas the Province is in the process of finalizing the evaluation of the ICIP projects submitted for funding under the Community, Culture and Recreation Funding Stream;

Whereas the Province is seeking confirmation that the Partners still intend to proceed with the West Parry Sound Area Recreation and Culture Centre (the “Project”) and fund the required municipal portion, 26.67% or \$8,507,934.69;

Whereas the Province is seeking confirmation that all costs determined to be ineligible by the Province or the Federal Government will be funded by the Partners;

Whereas the Province is seeking confirmation that sources of funding noted in the application are still available;

NOW THEREFORE BE IT RESOLVED THAT the Partners hereby confirm that there is no change in their commitment to the Project;

THAT the Partners commit to be responsible for any ineligible costs as stated in paragraph B 7 of the Business Case Section of the ICIP application;

AND THAT no additional Federal or Provincial monies will be requested to fund any revenue shortfalls as stated in paragraph B 3 of the Business Case Section of ICIP application.
